

CAS-PEAL Face Database Release Agreement

The ICT-ISVISION Joint Research & Development Laboratory (JDL) for Face Recognition has constructed the CAS-PEAL face database under the sponsor of National Hi-Tech Program and ISVISION Technologies Co., Ltd. The goals to construct the PEAL face database include (1) providing the worldwide researchers of FR community a large-scale face database for training and evaluating their algorithms; (2) facilitating the development of FR by providing large-scale face images with different sources of variations, especially Pose, Expression, Accessories, and Lighting (PEAL); (3) advancing the state-of-the-art face recognition technologies aiming at practical applications especially for the oriental. **Therefore, the CAS-PEAL face database is now made partly available for research purpose only on a case-by-case basis only.** JDL is serving as the technical agent for distribution of the database and reserves the copyright of all the images in the database. Any researcher who requests the CAS-PEAL face database must sign this agreement and thereby agree to obey the restrictions listed in this document. Failure to observe the restrictions will result in access being denied for the request of the future version of the PEAL database and being subject to civil damages in the case of publication of images that have not been approved for release.

The researcher(s) agrees to the following restrictions on the CAS-PEAL face database:

1. Only images whose face ID is less than 100 and labeled with "R1" label in the file name will be published or released in technical reports, papers in the face recognition research area only. Other images will never appear in any document of any form. Any images will never be released in commercial materials, newspapers, or other public medias.
2. The database will not be further distributed, published, copied, or further disseminated in any way or form whatsoever, whether for profit or not. This includes further distributing, copying or disseminating to a different facility or organizational unit in the requesting university, organization, or company.
3. All the images will be used for the purpose of scientific researches only. The CAS-PEAL face database, in whole or in part, will not be used for any commercial purpose in any form.
4. All technical papers, documents and reports which use the CAS-PEAL database will **acknowledge** the use of the database as follows: "The research in this paper use the CAS-PEAL-R1 face database collected under the sponsor of the Chinese National Hi-Tech Program and ISVISION Tech. Co. Ltd." and a citation to "Wen Gao, Bo Cao, Shiguang Shan, Xilin Chen, Delong Zhou, Xiaohua Zhang, Debin Zhao. *The CAS-PEAL Large-Scale Chinese Face Database and Baseline Evaluations. IEEE Trans. on System Man, and Cybernetics (Part A) vol.38, no.1, pp149-161. 2008.1*". And a copy of the published paper, reports and other documents that uses the CAS-PEAL face database will be forwarded to the JDL.
5. The final explanation of this agreement refers to the JDL.
